- 1. This form is used to apply for approval of the sale and purchase of non prohibited arms items and ammunition by mail order or on the Internet.
- 2. You may not take possession of any non-prohibited firearm, non-prohibited magazine, non-prohibited part, ammunition and/or pistol carbine conversion kit unless you have a current firearms or dealer licence.
- 3. If you are purchasing an airgun, you need to be 18 years of age or older if you do not have a firearms licence.
- 4. If you are purchasing a pistol carbine conversion kit, you need to also have:
 - a) an endorsement to possess a pistol; and
 - b) a pistol that you have recorded against your endorsement through a permit to possess or import; and
 - c) a permit to possess the pistol carbine conversion kit.
